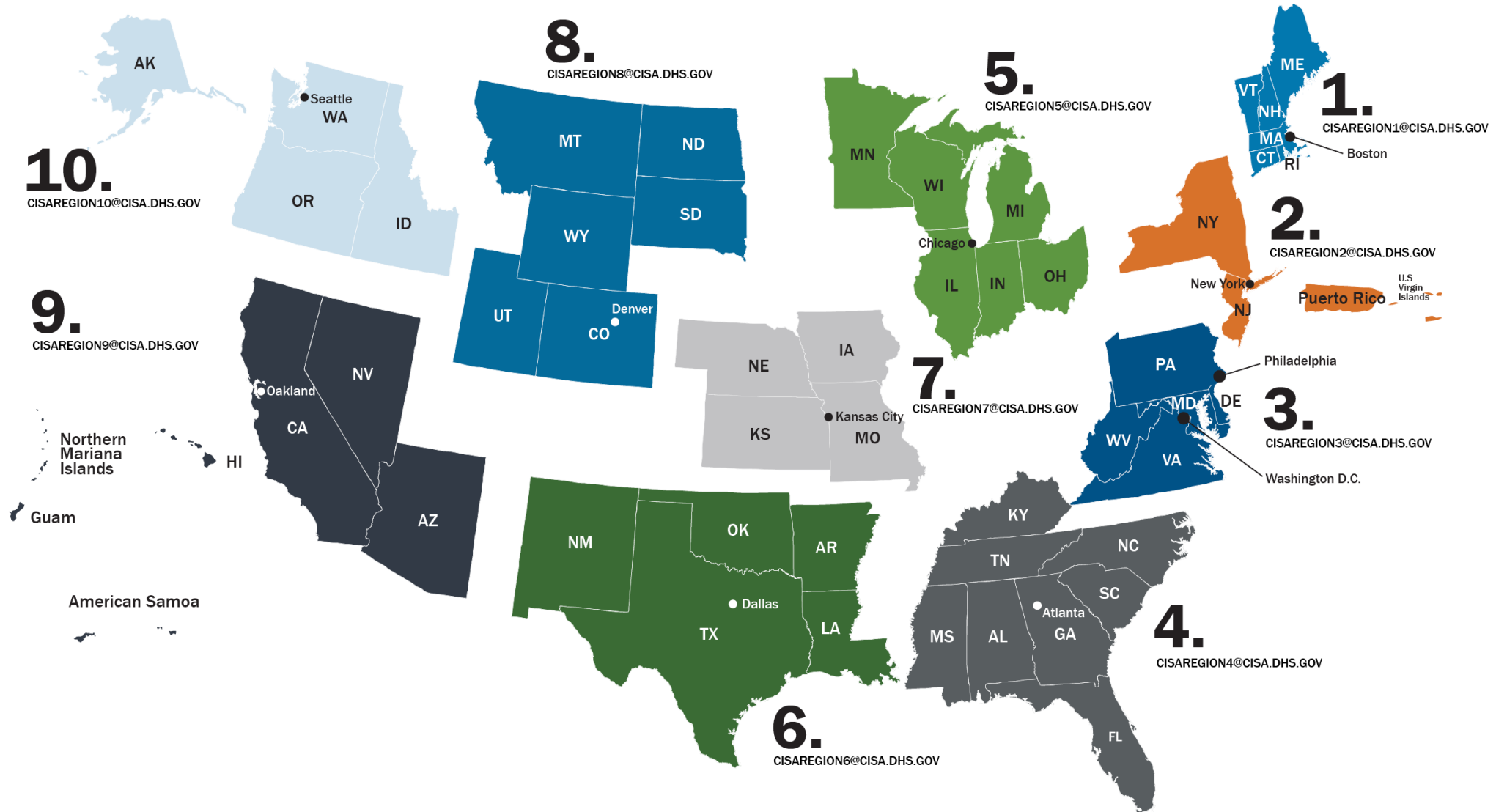

Chemical Security Inspectors (CSIs)

Role

- Chemical security subject matter expert in the region
- Implementation of ChemLock program
- Outreach to specific industry segments
- Outreach with local law enforcement, first responders, and emergency management

Services/Programs

- All Levels of Chemlock On-Site Assessments and Assistance
- In-person outreach to point-of-sale businesses that sell common consumer products containing explosive precursor chemicals (EPCs) that can be used to build a bomb
- Water and wastewater outreach
- Contribution to CISA and Infrastructure Security programs
- Incident and event response



Protective Security Advisors (PSAs)

Role

- Build Coalitions
 - Outreach and Engagement
 - Collaboration
- Understand Risk Factors
 - As-Is
 - To-Be
- Increase Capacity for Managing Risks

Services/Programs

- Working Groups
 - Prevention
 - Response
- Assessments
 - Facility
 - System/Enterprise/Community
- Planning Support
 - Security, Emergency Response, COOP
- Training and Exercise



Cybersecurity Advisors (CSAs)

Role

- **Assess:** Evaluate critical infrastructure risk
- **Promote:** Encourage best practices and risk mitigation strategies
- **Build Capacity:** Initiate, develop capacity, and support communities-of-interest and working groups
- **Educate:** Inform and raise awareness
- **Listen:** Collect stakeholder concerns and needs
- **Coordinate:** Bring together incident support and lessons learned

Services/Programs

- **Cyber Protective Visit (CPV):**
 - Gauge interest in CISA services, understand the organization's needs, and develop the foundation for further engagements and offerings
- **Cyber Hygiene (CyHy) Vulnerability Scanning:**
 - Maintain enterprise awareness of your internet-accessible systems
 - Provide insight into how systems and infrastructure appear to potential attackers
 - Drive proactive mitigation of vulnerabilities and reduce risk
- **Ongoing Partnership:**
 - Information sharing, assessments, tabletop exercises, presentations, connection to resources, incident support



Regional Training and Exercise Coordinator (RTEC)

Role

- Enhance the security and resilience of our nation's critical infrastructure by providing stakeholder-focused cyber and physical security training
- Plan, build, and execute discussion and operations-based stakeholder tabletop, functional, and full-scale exercises
- Facilitate seminars, workshops, and drills for stakeholders across all 16 critical infrastructure sectors
