INTRODUCTION

The following worksheet is derived from the Continuity Capability Evaluation for the Emergency Services Sector (CCE) to assist Emergency Services Sector organizations in evaluating and filling gaps in their continuity capability. For more information, visit the <u>Emergency Services Sector</u> <u>Continuity Planning Suite</u>.

Continuity facilities are locations from which leadership and critical positions may operate during an emergency. These may include one or more facilities or virtual offices from which to continue essential operations. The use of continuity facilities, alternate uses of existing facilities, and telework options enhances the resilience and continuity capability of organizations. Continuity facilities are typically classified as one of three types:

- Hot site: A facility that already has in place the personnel and physical, communication, and information technology (IT) infrastructure required to recover essential functions.
- Warm site: A facility that is equipped with some personnel and physical, communication, and IT infrastructure capable of providing backup after additional personnel, equipment, supplies, software, or customization are provided.
- Cold site: A facility that is not manned on a day-to-day basis. Before it can be used, organizations may be required to install communications and IT infrastructure and deploy designated essential personnel to the facility to activate equipment or systems.

This capability can encompass separate facilities; alternate uses of existing facilities; and, as appropriate, work arrangements, including telework and mobile work.
