**Cybersecurity and Infrastructure Security Agency (CISA) Office of the Chief Counsel (OCC)
Infrastructure Security and Regulatory Programs Law Attorney Detail**

Detail Location and Description: Opportunity to serve as an Associate Chief Counsel for the Infrastructure Security and Regulatory Programs Law Division (ISRP), Office of the Chief Counsel (OCC), Cybersecurity and Infrastructure Security Agency (CISA), Department of Homeland Security (DHS).

Summary: This developmental opportunity will give the detailed attorney high-level experience in managing and directing the provision of legal support on infrastructure security programs and regulatory programs conducted by CISA and its divisions. The detail will provide an opportunity to obtain a deeper understanding of providing advice, interpretations of law, and guidance on matters arising under the Homeland Security Act, the Cybersecurity and Infrastructure Security Agency Act of 2018, the Administrative Procedure Act, and other statutes and regulations related to CISA's infrastructure security programs or regulatory programs. The detailed attorney will primarily oversee the delivery of legal advice and support to CISA's Infrastructure Security Division but as a part of the OCC Management Team may work on issues that cross several of CISA's divisions and subdivisions. The detailed attorney will work directly with other attorneys in OCC and the Department to address supporting areas of law, including ethics, intellectual property, administrative law, fiscal law, and procurement law. The detailed attorney will represent OCC, CISA, and DHS in engagements with other agencies, the public, Congress, state and local governments, and the private sector to support CISA's programs. There will be opportunities to negotiate complex and unique issues to advance and benefit CISA programs. The detailed attorney responsibilities may include managing administrative and personnel matters, including monitoring workloads and resources, making recommendations on resource needs and allocation, and making recommendations on personnel actions for at least six employees.

Qualifications: Applicant must (1) be an attorney at GS-15 level (or equivalent), (2) have experience analyzing existing authorities, (3) be familiar with assessing the impacts of new legislation on agency's mission, and (4) have the capacity to render legal advice in a fast-paced, highly-charged, and fluid environment.

Detail term: The period for this detail will be for 120 days and may be extended. The successful applicant's supervisor will be consulted before a selection is made. During the detail period and for a period of one year from the end of the detail, CISA OCC will not hire any detailed attorney selected under this announcement.

How applicants will be evaluated: Resumes will be reviewed by the CISA OCC Deputy Chief Counsel for Infrastructure Security and Regulatory Programs.
