LME also provides information technology (IT) administrators visibility into who is accessing their network and offers centralized logging, enhanced threat detection, and better cyber hygiene.

# **HOW CAN I DOWNLOAD LME?**

No sign-up or lengthy onboarding is required. Simply visit LME's GitHub page for step-by-step instructions on how to download and install the tool. GitHub supports open source software communities where developers create, store, manage and share code. LME instructions are organized by chapters with detailed steps that break down how the tool uses endpoint agents for thorough event data collection and analysis.
