Technology Policy (Joint with SAFECOM)

- ▶ The Technical Policy Committee Meeting was held on August 1
- ▶ The committee received updates from the Federal Partnership for Interoperable Communications (FPIC), the Identity, Credential, and Access Management (ICAM) Working Group, and the Next Generation 9-1-1 (NG 9-1-1) Working Group
- ▶ Members continued discussions on committee work products such as the Public Safety Grade White Paper and Request for Proposal (RFP) Best Practices for Subscriber Units
- ▶ Members agreed to focus on RFP Best Practices for Subscriber Units in preparation for the November 7, 2017 In-Person Committee Meeting

ICAM Working Group

- ▶ The ICAM Working Group is focused on creating discipline-specific education and outreach materials for fire, law enforcement, EMS, 9-1-1, and emergency management

NG 9-1-1 Working Group

- ▶ The NG 9-1-1 Working Group held its kick off meeting on August 28, 2017
- ▶ The working group will be chaired by SAFECOM member Mark Buchholz, Director Willamette Valley (Oregon) 911 Communications Center, and vice chaired by Jennifer Kirkland, Operations Support Supervisor Vail Public Safety Communications Center
- ▶ Members agreed to compile a document that surveys the various NG 9-1-1 activities among SAFECOM member organizations
- ▶ The NG 9-1-1 Working Group plan to meet in person on November 9, 2017 in Norman, Oklahoma

 - Phase I sections will be presented to the SAFECOM and NCSWIC membership in a webinar on September 25, 2017; comments will be accepted; final version of Phase I sections will be presented to the SAFECOM and NCSWIC ECs for review and approval at the November 8, 2017 EC In-Person Meeting
 - Phase II sections will be developed and reviewed at the November 7, 2017 Funding and Sustainment Committee In-Person Meeting
 - Requested Product Champions for Lifecycle Guide Sections
