- ▶ Brainstormed additional Education and Outreach Committee products

### Communications Unit (COMU) Working Group

- ▶ Discussed the Working Group sub-group structure to ensure each effort and product has the resources and support needed to successfully carry out its mission and product development

### Funding and Sustainment

- ▶ Discussed the recent award of the FirstNet contract, and noted the continued need to continue to educate and communicate with elected officials and decision-makers on the entire communications portfolio
- ▶ Distributed the life cycle survey to SAFECOM and National Council of Statewide Interoperability Coordinators (NCSWIC) members which will be used to estimate life cycles, and inform future *Life Cycle Planning Guide* sections
- ▶ Finalized four sections of the *Life Cycle Planning Guide*: Introduction; Pre-Planning; Planning; Acquisition

- ▶ Continued discussion on Public Safety Grade definition and white paper
- ▶ Conducted working session on a Request for Proposal (RFP) for subscriber units to draw out best practices for administering the RFP process

- ▶ Received updates on Federal Partnership for Interoperable Communications (FPIC) activities and initiatives
